Thanks for your time on the phone earlier this week. I write to share my opinions on the zoning draft on accessory dwelling units (ADUs).

My husband and I live at 805 Stonewall St (technically Stonewall St Extension) on a long driveway one an acre lot off the golf course in Providence Hill area. We are in the preliminary stages to consider building a cottage on our property. We support allowing accessory dwelling units to the maximum of 40% of the main house sq ft or 1,000 square feet. The balance between lodging units on a house lot are important, as well as the ability to house a small family (2 adults and one child). This is why I support a max of 1,000 sq ft over the 800 in the current draft.

Like I said, we are still in the early stages. Appreciate your work to define the code so we know our options better. We will follow online and in the local newspapers.

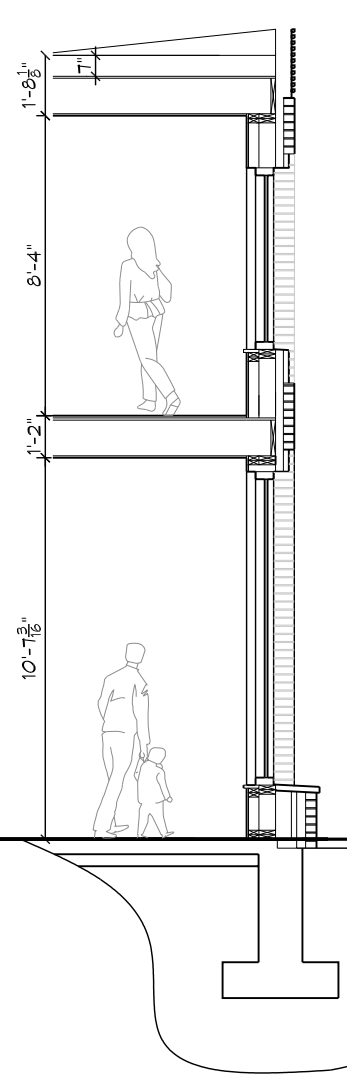

SOUTH ELEVATION



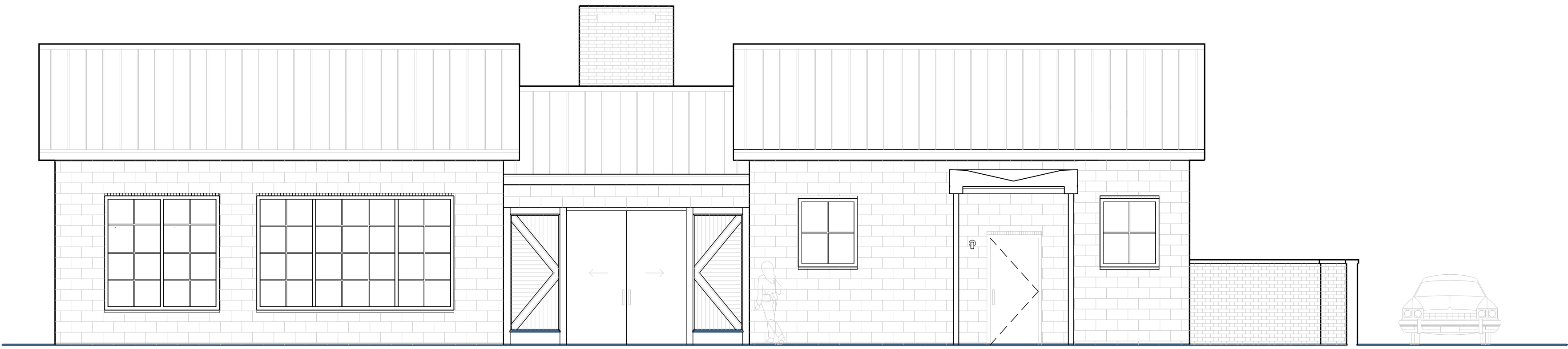

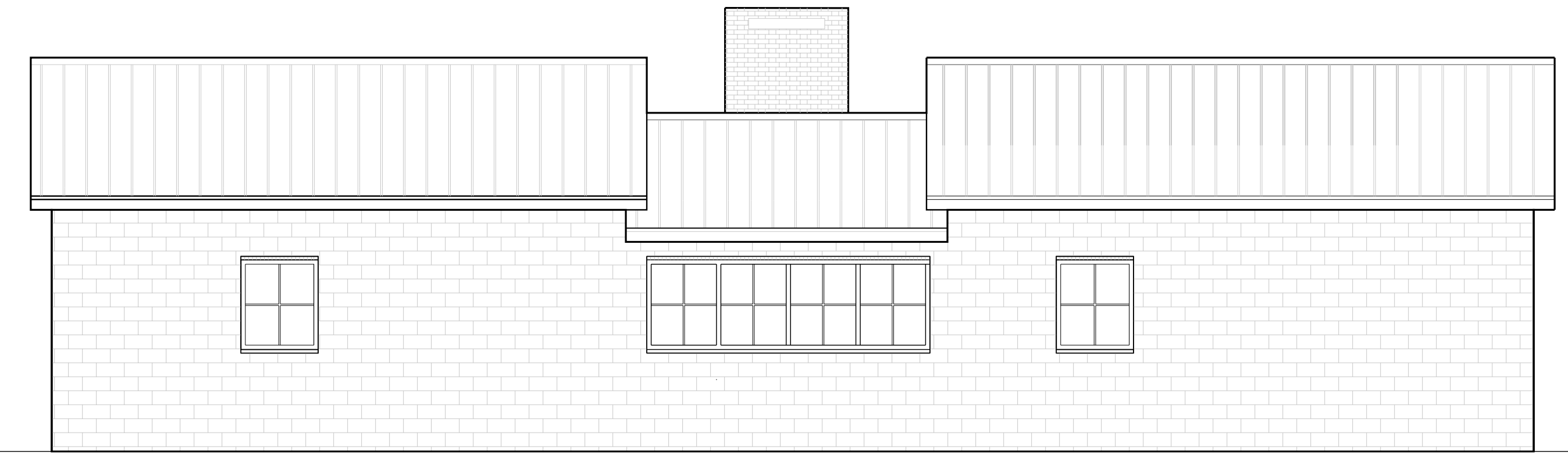

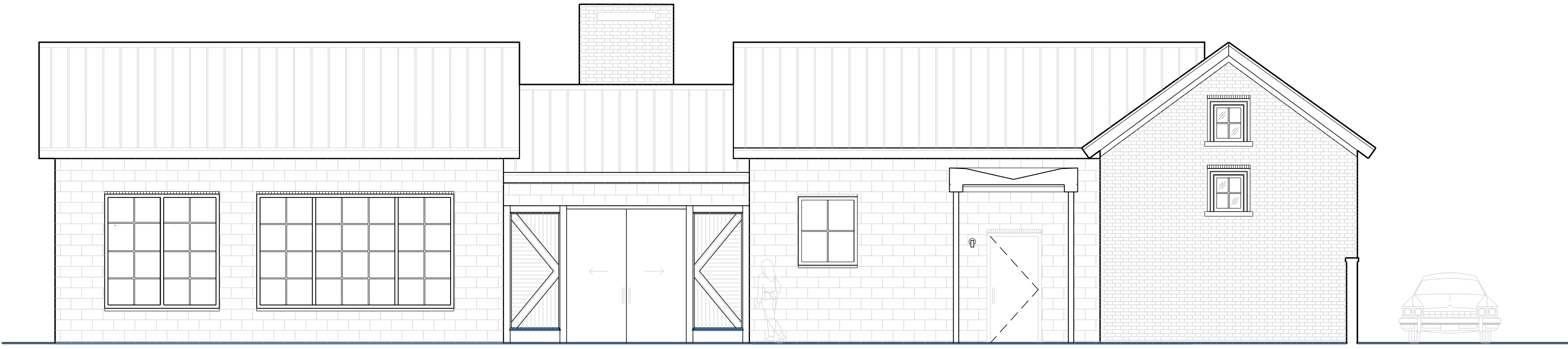

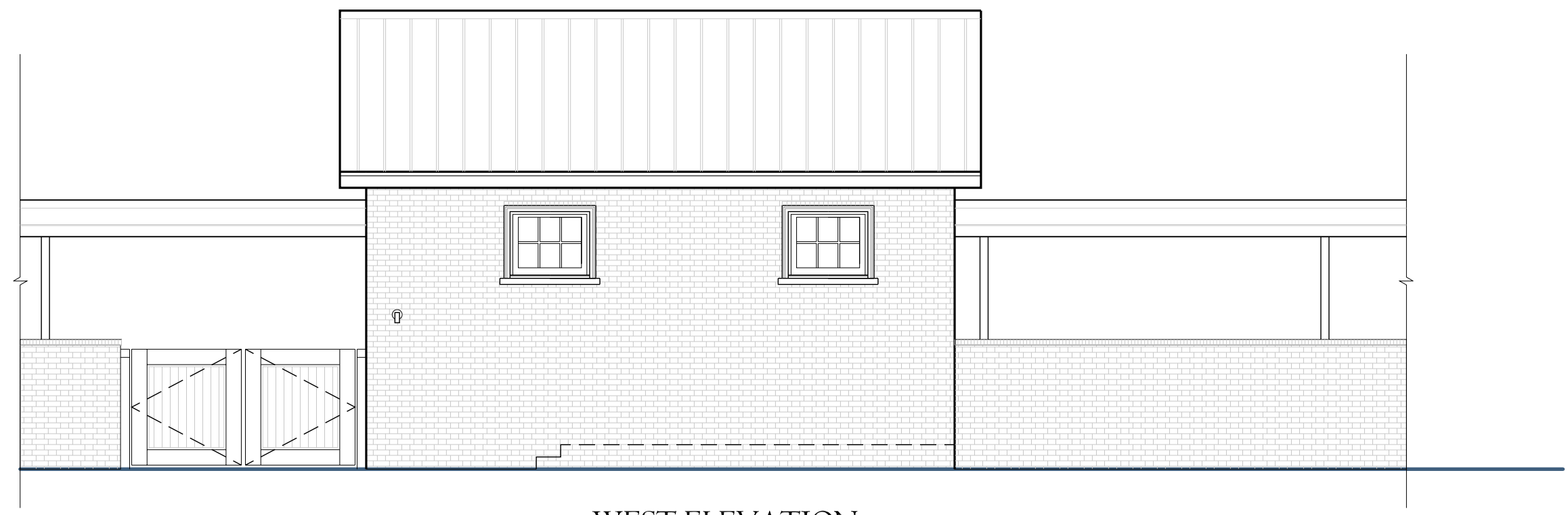
